ABOUT THE PLAN

Well known for its large historic district and quaint but vibrant downtown, the City of York offers a unique quality of life amidst the rapid growth of York County and Charlotte Metro Area. Current and future population growth place new demands on City services, including parks and recreation facilities.


In 2019, the City of York developed a 2019 – 2029 Comprehensive Plan to provide a framework for efficient use of public funds, future growth, and development and redevelopment of the jurisdiction. Building on the Comprehensive Plan, the York Parks Master Plan provides a 10 year vision and foundation for parks and recreation projects and programming specifically.

With 9 parks, a one-mile Bike Trail, and two leased fields (one from York School District 1 and one from York County) the Parks Master Plan not only evaluates how the current park system serves the surrounding community but also looks to the future to understand how the park system needs to serve future generations.

ABOUT THE PROCESS

The York Parks Master Plan is a culmination of detailed facility assessments, thorough staff, stakeholder and public input, and a comprehensive needs assessment. Through this planning process, a Capital Improvement Plan was developed, which provides as an effective tool and guide for the City of York on park project recommendations and priorities. The planning process consisted of three phases as outlined below.

2. Plans, Policies + Resources



New Street Park

The purpose of this chapter is to review existing City of York plans and policies that provide a framework for not only the City's growth but also potentially the future of City park facilities and recreation programs offered. Additionally, this chapter will also provide a snapshot of existing recreation programs and resources with the City providing a baseline when reviewing existing facilities and identifying future needs.

PLAN REVIEW

1. City of York Comprehensive Plan 2019 – 2029 Adopted December 3, 2019

The City of York Comprehensive Plan 2019 – 2029 represents a revision of the Plan developed in 1999 and updated in 2005. The Plan reviews existing conditions in ten subject areas, provides Guiding Principles that list goals, objectives, and implementation strategies for each of the eight elements, and a Land Use Map illustrating the recommended patterns of growth for the future. The following elements from the updated Comprehensive Plan provide a framework for the York Parks Master Plan.

Population Element

The York Comprehensive Plan identifies steady population growth in the City of York and the York Planning Area area over the past four decades due to a variety of factors. The City's corporate limits have also expanded and it is projected that York's population will continue to increase and projects a 1.5% annual growth rate. The Plan notes that increasing population places an increased demand on the public sector.

Natural Resources Element

The Plan reviews the City's existing park system which entails (see map on next page):

- Two major facilities:
 - York Recreation Center
 - York Recreation Complex
- Seven neighborhood parks:
 - Moore Park
 - City Park
 - Green Street Park
 - Lincoln Park
 - Magnolia Street Park
 - New Street Park
 - Wooded Valley Park
- Two field facilities:
 - Jefferson Field (leased from York School District #1)
 - McCelvey Field (leased from York County)

Actions identified in the Plan to upgrade the recreation facilities within the City of York in the past several years include:

- Neighborhood parks have been improved to make them more usable and attractive through the addition of benches, trash cans, grills, and picnic tables. A majority of these improvements were made possible in through state PARD grant funds.
- Playground equipment at Lincoln Park was replaced in 2008 through grant funds to provide safe and modern equipment for children to enjoy.
- Improvements at the York Recreation Center were made in 2005 and include a new metal roof, gym floor, interior painting and other interior improvements. These improvements will extend the life of the facility by 25 years.
- Improvements to the York Recreation Complex have been made throughout the course of its lifespan. In 2009, shade covers were installed over the bleachers in to provide shade to spectators.




In 2014, picnic tables and umbrellas were replaced at the York Recreation Complex. In 2015, Improvements were made to restroom facility sinks. In 2017, pavement repairs were made to walking trails at the complex. Also in 2017 part of the horseshoe court area was converted to a dog park to make better use of the fenced in area. In 2018, deteriorating playground equipment was replaced.

- Although the staff of York’s Parks and Recreation Department has not been expanded, the Department continues to provide a high level of service through activities and facilities to meet the growing demand for recreation.
- Signage has been added at all parks to identify the park name, address, and hours.
- In 2018 the playground equipment was replaced with an updated and safer equipment for kids to enjoy.

The Plan identifies that the land area within the City limits of York is largely developed. Areas unsuitable for urban development include flood plain areas and areas with steep slope, which lend themselves to protection as open space. York County has created York County Forever, which has a goal of protecting one acre of open space per one acre that is developed in the County. There are currently no protected natural areas in the York Planning Area.

Priority Investment

The Priority Investment element serves to connect the major capital improvement needs identified in the other elements of the Comprehensive Plan. York uses the Capital Improvement Plan as the financial tool to implement their comprehensive plan. Parks and Recreation projects in the CIP include:

Land Use Element

Future land use patterns included by a number of factors including the availability of public services and external growth factors like the continued expansion of the Charlotte-Rock Hill urban area. The Plan notes that residential growth will continue at a steady pace due to large areas of vacant land within the City limits suitable for single family residential. Additionally, the Plan notes that the health and economic viability of the downtown area is a major concern being that it serves multiple functions.

Land Use Plan

The purpose of the Land Use Plan is to provide a general development pattern for the future growth and development of York. It is a vision of the development pattern over a twenty year period. Under Open Space/Recreation, the Plan recognizes the large expansion of public recreation opportunities in the City over the past few years. The following are recommendations provided:

- Recommendation for continued provision of public open space for active and passive recreation.
- Recommendation to begin long-range planning for second major recreation complex due to the heavy use experienced at York Recreation Complex
- Recommendation for a system of trails and biking trails be implemented in the York area.
- Recommendation to preserve open space along major drainage courses and floodplains.
- Recommendation that greenways and corridors of open space will help to maintain the small town character.

Guiding Principles Appendix - Natural Resources

- Enhance and expand recreational resources for the citizens of York.
- Encourage the preservation and connectivity of green spaces, natural areas, and air and water quality.

2. City of York Strategic Plan Project Combined Focus Group Review Project in Process

The York Strategic Plan Project’s purpose is to:

- Guide the future of City facilities, services and programs, and
- Help City Council develop short-to mid-tern (3 – 5 years) strategic goals and plans.

The Combined Focus Group Review presentation provides a summary of residents’ opinions of services and programs and identifies opportunities for new programs, services, and facilities identified by residents.

Focus groups met virtually in September and October 2020.

Big Ideas gathered from the focus groups related to parks and recreation include:

- Improve Jefferson Field and City Park
- Maintain current facilities
- Expand traditional youth recreation programs to include new cultural programs like art, music, theater and pottery
- Enhance adult recreation programs
- Maintenance, Appearance and Beautification of Parks, Bike Trail
- Pedestrian Improvements
- More trails, parks and green space that connect the City, neighborhoods and assets and increase signage
- Wayfinding signage

Review of the Strategic Plan Project Community Survey

- 279 residents conducted the survey.
- Good distribution of age, neighborhood and household size.
- See appendices for survey responses related to parks and recreation.

3. City of York Bicycle and Pedestrian Infrastructure Study Completed 2016

The York Bicycle and Pedestrian Infrastructure Study examines existing conditions, provides a network gap analysis, lists and ranks capital improvement projects, and delivers important base maps to guide future bicycle and pedestrian enhancements. This study analyzed 90 road corridors and 47 intersections within the City of York examining curb ramps, tactile warning domes, sidewalk, crosswalks, pedestrian signals, county bike routes, rail trail, and any other on street bike facilities.

Impacting accessibility to the existing City parks, recommended improvements include

- Crosswalks
- N. Congress Street updates and bike hub
- Addressing missing curb ramps
- Access to Jefferson Street
- Provide connections to the York Bike Trail.

Specifically, the study also highlights the following issues on the York Bike Trail:

- Limited to zero pedestrian and bicycle infrastructure connecting to trailheads on Raille Street, 4th Street and the York Recreation Complex.
- All trailheads need enhancements to better guide trail users and create a user friendly experience. Additionally, there is an opportunity to better brand and market the trail with cohesive trailhead amenities including signage, maps, and landscaping.
- Certain portions of the trail feel enclosed with fences and vegetation creating a lack of visibility for trail users and therefore, impacting perception of safety along the trail.
- There is no crosswalk for trail users when crossing Blackburn Street.
- Signs are needed along Madison Street, Blackburn Street, and 4th Street to connect people with the trail and create more visibility about the trail.

POLICY REVIEW

The following references to parks and recreation were identified in the City of York's Code of Ordinances.

Chapter 18 - Floods

Article II - Flood Damage Prevention

Section 18-33

Floodplains are an important asset to the community. They perform vital natural functions such as temporary storage of floodwaters, moderation of peak flood flows, maintenance of water quality, groundwater recharge, prevention of erosion, habitats for diverse natural wildlife populations, recreational opportunities, and aesthetic quality. These functions are best served if floodplains are kept in their natural state. Wherever possible, the natural characteristics of floodplains and their associated wetlands and water bodies should be preserved and enhanced. Decisions to alter floodplains, especially floodways and stream channels, should be the result of careful planning processes that evaluate resource conditions and human needs.

Chapter 30 - Parks and Recreation

Article II - Recreation Director

Section 30-31 - Appointment

The city manager shall appoint a parks and recreation director who shall have the qualifications, training and experience necessary to develop and administer a coordinated program of recreation services for the city and surrounding service areas outside the city. The director and all personnel under him shall be responsible to and under the direct supervision of the city manager.

Article III - Non-City Resident Recreation Charges

Section 30-66 - Authorized

The city council hereby establishes a system of annual charges for the use of the city's recreational facilities and programs. Charges as established and set shall apply only to those facility and program users not residing within the corporate limits of the city. Such charges shall be in addition to any facility and program fees normally charged all users to defray program expenses. Program fees for non-city residents are charged at double that paid by city residents. A schedule of the current charges is on file and available in the city offices.

Chapter 36 - Solid Waste Management

Article I - In General

Section 36.5 - Litter in parks

No person shall throw or deposit litter in any park except in public receptacles, and in such a manner as to prevent the litter from being scattered or carried by the elements onto any part of the park, upon any street or other public place. Where public receptacles are not covered, all litter shall be carried from the park by the person responsible for its presence and properly disposed of elsewhere.

Chapter 38 - Streets, Sidewalks and Public Places

Section 38-17 - Operation of skates and similar riding devices

- (a) Except where expressly permitted, no roller blade skates, regular skates, skateboards or other similar rolling or riding devices shall be operated upon any pedestrian/bicycle pathway in the public parks or public recreational areas or upon any roadway or public sidewalk.

Chapter 44 – Utilities

Article IV – Sewer Use

Division 2 – Regulations

Section 44-200 Use of Public Sewers

d. The owner of all houses, buildings, or properties used for human occupancy, employment, recreation or other purpose situated within the city and abutting any street, alley, or right-of-way in which there shall be located a public sanitary sewer of the city is hereby required at his expense to install suitable toilet facilities therein and to connect such facilities directly with the proper public sewer in accordance with provisions of this resolution within 60 days after written notice from the city to the property owner requiring such property owner to make connection thereto, provided that said connection to public sewer shall be technically feasible.

Appendix A – Zoning

Section 8 – Zoning Districts

1. - R-15 Restricted residential district

B.6 Permitted uses include public parks or recreational facilities.

3. - R-7 Residential District

B.1 Permitted Uses includes any use permitted in the R-15 residential district.

5. - R-5 Multifamily residential district

B – All uses permitted in R-15 and R-7.

F.4 Uses allowed by special exception includes public parks

F.2 Uses allowed by special exception includes recreation facilities

6. – MH mobile home park district

B.3. Permitted uses includes recreation buildings and areas serving only the mobile home district in which they are located.

Section 11 – Off Street Parking Requirements

4. Parking Requirements

Ball Park – One (1) space for each four (4) spectator seats

Section 15 – General and Supplemental Regulations

3. – Cluster Housing

2. Density and Recreation Area:

a. The maximum overall density for a planned cluster development shall be in terms of the number of dwelling units per gross acre of land within the development, as provided in the table below.

b. The minimum total recreation area (that part of the living space which is any large

contiguous area for recreation purposes) shall be provided at no less than a minimum ratio of recreation space area per total floor area, as provided in the table below. Recreation areas shall be of common ownership.

R-7	6	0.14

5. Accessory Uses

3. Uses customarily accessory to retail businesses, offices and commercial recreation facilities:
 - a. Off-street parking or storage area for customer, client or employee-owned vehicles.
 - b. Completely enclosed building for the storage of supplies, stock or merchandise.
 - c. Light manufacturing and/or repair facility incidental to the principal use; provided that dust, odor, smoke, noise vibration, heat or glare produced as a result of such manufacturing or repair operation shall not be perceptible from any boundary line of the lot on which such principal and accessory uses are located; and provided that such operation is not otherwise specifically prohibited in the district in which the principal use is located.
 - d. One single-family dwelling for a miniwarehouse development, provided that the dwelling must be used by an individual employed for the purpose of providing security for the miniwarehouse development. Manufactured homes (mobile homes) are prohibited from use for the above-referenced residential purpose.
 - e. Offices shall be allowed when associated with apartment complexes.

Appendix B - Subdivision Ordinance

Article 5 Design Standards

V-8 Development Standards

8.3 Open Space


1. A minimum of 10% of the subject development shall be dedicated as open space.
2. The following features shall be incorporated into the open space:
 - a. Public access to the open space shall be provided for all property owners;
 - b. Public recreation facilities shall be provided per the Planning Commission and the City’s Comprehensive Plan;
 - c. The connection of adjacent open spaces is encouraged;
 - d. The open space shall be usable (i.e. topography, drainage, etc. shall not preclude public usage of the property);
 - e. Open space shall be contiguous as much as possible;
 - f. Open space shall not include public right-of-way, required setbacks, parking areas, or lot area for individual residential lots.
3. The developer shall specify the following regarding the proposed open space:
 - a. Designate areas to be reserved as open space. The specific design of open space areas shall be sensitive to the physical and design characteristics of the site;
 - b. Designate the type of open space that will be provided;
 - c. Specify the manner in which the open space shall be perpetuated, maintained and administered.

4. The types of open space allowed are as follows:
 - a. Natural areas are areas of undisturbed vegetation or areas replanted with vegetation after construction. Woodlands and wetlands are specified types of natural areas. Maintenance is limited to removal of litter, dead trees, plant materials and brush. Natural watercourses are to be maintained as free-flowing and devoid of debris. Stream channels shall be maintained so as not to alter flood plain levels;
 - b. Recreational areas are designed for specific active recreational uses such as tennis courts, swimming pools, club houses, ball-fields and the like or passive recreation such as tot lots, picnic areas, walking and bike trails, ponds with designated swimming and fishing areas and the like or similar uses. Recreational areas shall be accessible to all residents of the development. Maintenance shall insure that there exists no hazard, nuisance or unhealthy conditions.
 - c. Greenways are linear green belts linking residential areas with other open space areas. These greenways may contain bicycle paths, footpaths, and bridle paths. Connecting greenways between residences and recreational areas are encouraged. Maintenance shall insure that there exists no hazard, nuisance or unhealthy conditions.
5. Land designated as common open space may not be separately sold or developed. Open space areas shall be maintained so that their use and enjoyment as open space are not diminished or destroyed. Open space areas may be owned, preserved and maintained as required by this section by any of the following mechanisms or combinations thereof:
 - a. Dedication of an acceptance by the governing authority;
 - b. Common ownership of the open space by a homeowner's association that assumes full responsibility for its maintenance; or
 - c. Deed restricted, private ownership that shall prevent development and/or subsequent subdivision of the open space land and provide the maintenance responsibility.
6. In the event that any private owner of open space fails to maintain same, the City, in accordance with the open space plan and following reasonable notice can demand that deficiency of maintenance be corrected, enter the open space to maintain same. The cost of the maintenance shall be charged to those persons having the primary responsibility for maintenance of the open space.

EXISTING RESOURCES

Staff

The City of York Parks and Recreation Department currently has eight full-time staff, two part-time staff and contract lawn care employees.


Youth Athletics and Fitness

Since 2015, organized youth sports peaked in 2019 with the number of participants at 1,027 (90 teams). Due to the COVID-19 pandemic, however, 2020 program offerings were limited and therefore, program participation significantly impacted. Prior to 2020, baseball saw the largest increase in participation in 2019, with softball, basketball, and cheerleading all increasing and football decreasing.


Youth Athletics Participation and Teams 2015 - 2020


COMMUNITY DEMOGRAPHIC PROFILE

The demographic analysis provides an understanding of the population within the City of York and highlights key characteristics like age, income levels, education attainment, race, and ethnicity. This information plays a key role in informing the City of York and the Parks Master Plan as to who the park system serves, as well as identifies growth trends allowing the City to plan a park system to meet current and future needs. All demographic data is from the United States Census of 2010 and the United State Census Bureau 2015-2019 American Community Survey unless otherwise noted.

Population


The City of York has experienced stable growth in the past 10 years. From 2010 to 2019, York’s population increased 8.3% from 7,736 to 8,412 (United States Census Bureau’s Population Estimates Program). As noted in the 2019-2029 Comprehensive Plan, the rapid and continued growth of the Charlotte Metro Area will have an increasing impact on York. The City of York is projected to increase to 9,368 residents in 2025 and to 10,098 in 2030 (2019-2029 York Comprehensive Plan).


City of York Population Density



Age

The median age in the City of York is 37.2, slightly younger than both the York County median age (38.7) and South Carolina median age (39.4). The age distribution of the City is somewhat balanced between age segments. In 2019, residents 55 and older represented the highest percent of the population at 30% while 0 to 18 years old and 35-54 years old represented the lowest percent of the population each at 23%.




City of York Median Age

City of York Population by Sex














City of York Percent in Poverty







PUBLIC INPUT OVERVIEW

Community input and feedback regarding the existing City of York park system as well as parks and recreation needs and priorities were captured through a variety of methods including two self-guided public workshops hosted at the York Recreation Center, two pop-up public workshops at local churches, an online public survey, and interviews with an appointed, 7-member steering committee. Throughout the master planning process, over X people participated. This chapter provides an overview of findings for each public participation method.

Steering Committee Summary

On February 18, 2021, the York Parks Master Plan Steering Committee provided detailed feedback on existing conditions and needed improvements for each City of York Park. Additionally, the committee also brainstormed about the future of the parks system both short (5 years) and long term (10 – 15 years). Key takeaways are listed below. For full detailed notes from the steering committee meeting, please see the appendices.

Key Takeaways

- Jefferson Field is viewed as a key community resource and top priority for funding.
- The small neighborhood parks (Green Street Park, New Street Park, Wooded Valley Park) need to be re-imagined.
- As planning for improvements and new facilities, it is important to create spaces that engage kids and get them outside.
- Parks should be designed for all ages and abilities.
- Parks need to be safe and feel safe.
- Walking paths and gathering spaces are important community assets to have.

First Public Workshop and Survey Summary

From March 24, 2021 through April 9, 2021, posters highlighting the City of York's existing park facilities were available for public review at the York Recreation Center during operating hours. The public was able to provide feedback about current park usage and desired park facilities through a York Parks Survey. Printed copies of the survey were available at the Recreation Center and the survey was also available online. The existing conditions posters and printed surveys were also available at two COVID-19 vaccination sites hosted by the City including March 20, 2021 at Episcopal Church of the Good Shepard and on March 25, 2021 at Clinton AME Methodist Church. In total, 116 people participated and responded to the survey. The survey could be accessed online through the City's website as well as a QR code and link distributed by the City. The self-guided workshop and survey were advertised on the City's website, the City's social media platforms and through a Parks and Recreation email list.

First Public Workshop and Survey Summary (cont.)

The following page highlights key data captured from the survey. A full, detailed survey results summary can be found in the appendices.

Existing Park Facilities

- Green Street Park, Jefferson Field, Magnolia Street Park, McCelvey Field, New Street Park, and Wooded Valley Park had the highest percent of “Poor (functional but needs attention)” ratings, while the York Recreation Complex and York Recreation Center each received the highest percentage of “Fair (adequate but needs updating)” and “Good (very few or no maintenance issues)” ratings.
- 58% of the respondents said that the current City of York park system meets their needs.
- The most frequently visited parks are:
 1. York Recreation Complex
 2. Bike Trail
 3. York Recreation Center.
- The least frequently visited parks are:
 10. New Street Park
 11. Magnolia Street Park
 12. Wooded Valley Park

Park Usage

- The most used current park amenities are:
 1. Paved walking trail
 2. Picnic shelters
 3. Outdoor basketball court
- Top reasons for visiting parks are:
 1. Enjoy nature/get outside
 2. Time with family and friends
 3. Exercise/fitness
- When visiting a park, the most important concerns are:
 1. Safety and security
 2. Quality of the park facilities
 3. Cleanliness of the park.

Future Park Facilities

- Respondents identified that the top five park facilities needed in the City of York are:
 1. Paved walking and biking trails and greenways
 2. Playgrounds
 3. Picnic shelters
 4. Splash pad
 5. Natural areas, outdoor exercise/fitness stations and multi-purpose fields (tie)

Programming

- Youth baseball, youth basketball and youth softball are the top three activities that respondents or someone in the household have participated in.
- The City of York's athletic and recreation programming received the highest percentage of "fair" ratings.
- Respondents identified that the top five desired programs are:
 1. Activities for older adults
 2. Nature/outdoor adventure activities
 3. Special events and festivals
 4. Yoga
 5. Special needs activities

Funding Priorities

- Respondents identified that the top three parks in need of short-term support are:
 1. York Recreation Complex
 2. York Recreation Center
 3. Bike Trail
- Respondents identified that making improvements or renovating and maintaining existing facilities is the top priority for future implementation. Second is adding more paved trails and greenways and third is develop more passive recreation.

Second Public Survey Summary

Draft concept plans highlighting recommended improvements for the existing York park system were made available to public for review on the City of York’s website from May 19, 2021 through May 26, 2021. During this time, residents could also provide feedback through an online survey on the City of York’s website. 104 people participated in the survey.

Survey participants had the opportunity to designate their level of agreement with the proposed improvements at each park, with 1 being strongly disagree, 3 being neutral, and 5 being strongly agree. The chart below highlights the weighted average for each park draft concept plan, all of which are above 3.00 (neutral), indicating general overall support for the proposed improvements.

In review of the open-ended responses for each draft concept plan, key takeaways include the following:

- There is strong support by survey participants to have fields in the York park system dedicated specifically to soccer and football.
- There is strong support by survey participants for a pool facility (indoor, outdoor, water features, etc).
- There is support for high quality basketball facilities (indoor and outdoor).
- There is support by survey participants for non-traditional recreation and athletic facilities including skate park, bike park, disc golf, and archery range. Skate park was mentioned most frequently of these elements in the open-ended responses.

6. Needs Assessment



City Park

NEEDS ASSESSMENT OVERVIEW

The needs assessment evaluates the existing City of York park inventory and programming offerings to identify opportunities and constraints with the current system. The first method of evaluation entails a review of National Recreation and Park Association (NRPA) park metrics as a benchmark for the City of York park system. The NRPA park metrics represent a comprehensive source of data standards and insights for park and recreation agencies gathered from thousands of park and recreation agencies across the nation. The data gathered was specific to agencies serving less than 15,000 residents and a budget up to \$1M. This benchmark data is a helpful tool to gain more funding support, improve operations and allow agencies to better serve their communities.

The second method of identifying park opportunities and constraints entails a park service area analysis. By mapping the current park system and placing a half mile buffer around each park (approximate 8-to-10-minute walk), this analysis geographically identifies areas that are within walking distance to a City park. This exercise helps determine if there are underserved areas in the community and gaps in the park system to serve all residents of the City of York.

PARK METRICS

Overall Park System

Currently, the City of York provides one park for every 701 residents, which is lower than the national median of 1,298. With 74 acres of parkland, there is 8.8 acres of park per 1,000 residents in the City of York. This is less than the national median of 13.8 acres, indicating that while the number of parks is sufficient, the size of the parks and total acreage is insufficient.

An additional benchmark in understanding how the City of York serves the community is number of full-time equivalent (FTE) staff. The current median for comparable agencies is 6.9 FTEs on staff for every 10,000 residents. Currently, the City of York has 10 FTEs for a population of 8,412, above the national median of comparable agencies.

Outdoor Park and Recreation Facilities

The largest surplus in outdoor park and recreation facility inventory is with baseball and softball fields. It should be noted, however, that the two sports currently share fields, making it difficult for scheduling the varying age groups and teams. Separate facilities should be reviewed. Additionally, the City of York also has a surplus in overlay fields. All of the baseball outfields are also used for the youth football program and cheerleading.

The largest deficit in facilities includes youth soccer fields, multi-use courts and multi-use fields.



SERVICE AREA ANALYSIS

The service area analysis reviews equitable access to a park facility for the City of York by placing a half mile buffer around the existing parks. A half mile on average takes 7 to 10 minutes to walk and is a measurement for walkability. More than a half mile walk could pose a barrier to access. As seen in the map below, the central core of the City has the best access to parks, while the peripheries are underserved, primarily in the northwest and southeast areas.

Serving as a consistent framework, the vision and goals will help guide the City of York decision making process for capital improvements, new facilities, park operations, and park maintenance.

The City of York provides a park system accessible to all ages and abilities that promotes community health and well-being and builds community connections.

1. Improve Existing Parks

Goal: Improve existing parks for York residents and surrounding planning area.

- Advance and complete improvements at Tier 1 parks identified in this report in next 2 to 3 years.
- Advance and complete improvements at Tier 2 parks identified in this report in the next 5 years.

2. Accessibility for All

Goal: Provide access to parks for all ages and abilities.

- Improve ADA access system wide with all parks.
- Provide play elements across the park system for all ages and abilities.

3. Community Connections

Goal: Create opportunities to bring people together and build community connections.

- Include high quality gathering spaces and seating in existing park improvements and future park development.
- Provide diverse, multi-generational recreation programs.

4. Interconnected Park System

Goal: Provide an interconnected, multi-modal network to connect users to parks.

- Improve bicycle and pedestrian connections to parks.
- Implement a standardized wayfinding sign program throughout the City to provide clear directions to parks and increase awareness.

Goal: Develop a cohesive park and recreation brand and image.

- Standardize signage including park entrance, park rules, and park information throughout the park system.

Goal: Provide safe and clean conditions for all users through regular and proper maintenance.

- Inventory existing conditions annually.

- Incorporate maintenance into the design and planning of future parks and improvements.
- Incorporate Crime Prevention Through Environmental Design (CPTED) when designing and planning future park and existing park improvements.
- Assess staffing needs for park improvements or new park development to ensure optimal maintenance of parks.

7. Plan for Growth

Goal: Provide new park facilities that address facility gaps and support a comprehensive and equitable park system.

- Work towards establishing a level of service standard of 13.8 acres of parkland for every 1,000 residents.
- Provide all City of York residents a park within a ½ mile walk.
- Using the level of service standards established in this report, annually examine how the City of York is meeting current and projected needs.
- Identify underutilized land for future park expansion efforts.
- Establish partnerships to expand a multi-use trail system.

8. Funding

Goal: Establish sustainable funding resources to maintain and enhance park system and programs as well as expand facility and program offerings.

- Identify new sustainable funding sources (grants, impact fee, etc.)
- Work with City Council to create a short- and long-term funding plan to implement identified park improvements in this report.

OVERVIEW OF EXISTING PARK RECOMMENDATIONS

This chapter provides recommendations for improvements to existing parks, which was identified as the number one priority for implementation in the first public survey. With 12 recreation facilities located across City limits, the City of York provides most residents a recreation facility within a half mile walk. However, the entire existing park system is in immediate need of renovations to improve park conditions and provide quality park facilities for residents and visitors. Most facilities are significantly past their lifespan, creating underutilized and outdated public spaces.



OVERVIEW OF FUTURE PARK RECOMMENDATIONS

This chapter provides recommendations for new future park facilities. Faced with meeting gaps identified in the existing park system as well as preparing for continued population growth, it is necessary for the City of York to identify and acquire land for new park facilities. Many of the existing park facilities serve small, localized neighborhoods. Larger parks for the entire York community to enjoy are needed not only to serve a broader audience but also to improve the current level of service of 8.8 acres of park land per 1,000 residents to 13.8 acres of park land per 1,000 residents.

NEW RECREATION CENTER/COMMUNITY CENTER WITH AQUATICS

The existing York Recreation Center does not currently meet the needs of the City of York. Outdated and compact, a larger, new facility better equipped to handle a variety of programs, events, and activities is recommended. In particular, a new up to date indoor basketball facility and aquatic center are facilities highly desired by the public as useful recreation facilities for all ages. The new recreation center will also serve as a core community hub and gathering space, providing new opportunities and spaces for the City of York.

NEW MULTI-USE FIELD SPORTS COMPLEX

The City of York park system is currently in need of multi-purpose sport fields for athletic programming. The baseball outfields at the York Recreation Complex and Optimist Field are utilized for youth football practices and games, impacting facility conditions and programming scheduling. A dedicated sports complex with multi-purpose sport fields will not only address these field use demands but also provide opportunities for new athletic and recreation programming and events. Other amenities like a walking loop trail, restrooms, and play areas should be included in the complex.

NEW COMMUNITY PARK


With many small neighborhood parks a part of the existing York park system, a larger 10- to 20-acre community park is recommended for passive recreation including play areas, community event space, and family/friend gathering areas.

Dog parks are one of the fastest growing amenities park and recreation agencies offer. Dog parks not only provide a safe place for pet exercise and socialization but also promotes community connections between park users. It also provides an opportunity for revenue for the City with sponsorships and memberships.

2 MILES OF NEW PAVED GREENWAY/MULTI-USE TRAIL

As the number one desired amenity by the public and identified as a large gap in the existing facility inventory, 2 new miles of paved greenway or multi-use trail in a nature based setting is recommended. Paved greenways promote exercise/fitness, spending time with family and friends, and connecting with nature, all of which are the top reasons identified in the first public survey as to why people in York use parks.

OVERVIEW OF THE CAPITAL IMPROVEMENT PLAN

Critical to the implementation of the parks master plan is having a sound understanding of costs associated with recommended improvements and prioritizing projects through a Capital Improvement Plan. The Capital Improvement Plan will provide short- and long-term guidance for City staff and City Council to improve and develop park facilities.

This chapter provides estimated capital costs for improvements to existing parks and estimated capital costs for new future park facilities. The estimated costs outlined in this chapter do not include the ongoing operations and maintenance costs for the park system. This is important for the City to review as improvements are made to ensure the appropriate resources are in place to support the park infrastructure.

After evaluation of public input, stakeholder input, park site evaluations with City staff, and reviewing gaps in the existing park system facilities, all of the recommended existing park improvements and recommended future facilities have been prioritized into a Capital Improvement Plan, providing an implementable action plan for City staff and City Council.

EXISTING PARK FACILITIES CAPITAL COSTS

The total estimated cost for recommended improvements to the existing City of York park system (both land owned and leased by the City) totals \$9.5 million. The following pages entail detailed opinion of probable costs for each park.

CAPITAL IMPROVEMENT PLAN

The existing and future park projects identified in this chapter have been categorized into four tiers of priority and timeline for implementation. Based on the condition of the existing park system, it is recommended to first address the needed improvements at all existing parks owned by the City of York. The improvements should be completed in totality at each park instead of piecemeal improvements scattered between each park. Total renovation of each park space will provide safe, accessible and engaging public spaces for the community to recreate, gather, and get outside.

Tier One Projects

Tier One projects are existing park improvements that are achievable for the City of York to implement in the next one to three years. Tier One projects include improvements at City Park and the Bike Trail. These two park facilities have been identified as a top priority based on public input, stakeholder input, addressing gaps in park facility needs, and the ability to implement in the short-term future.

Bike Trail

- The City of York has secured funding for enhancements to the trail including asphalt resurfacing, signage and kiosks, and bike racks. Implementing the additional recommended improvements will leverage this funding, creating a high-quality standard for paved greenways and multi-use trails in the City.
- The Bike Trail was identified through the first public survey as the third park facility in most need of support over the next 3 to 5 years.
- The Bike Trail was identified in the first public survey as the most frequently used facility in the existing City of York park system.

City Park

- The City of York renovated City Park in 2021 to include a splash pad, two picnic shelters, and a paved trail for walking and running.
- The City of York is currently working to advance phase two renovations which include a restroom and outdoor stage.
- Phase Two renovations were heavily supported by the public in the second public input survey.
- Phase Two improvements will leverage funding already invested into the park by completing a full renovation of the park, as recommended with all other park facilities in this report – complete in totality to provide a high quality park facility rather than piecemeal improvements.

Tier Two Projects

Tier Two projects include the remaining existing park improvements on park land owned by the City of York. The City should aim to secure funding and complete Tier Two projects in the next three to five years. Tier Two projects include improvements at York Recreation Complex, Lincoln Park, Optimist Field, New Street Park, Magnolia Street Park, Wooded Valley Park, Moore Park, and Green Street Park.

Tier Three Projects

Tier Three projects include existing park improvements on park land leased by the City, which is Jefferson Field (owned by York School District 1) and McCelvey Field (owned by York County). City staff and City Council will need to discuss the future of these two leased properties, how they function for the City park and recreation system, and how and if the City envisions utilizing the fields as York continues to grow.



Map of Tier 1, Tier 2 and Tier 3 Projects



FUNDING SOURCES

This chapter outlines opportunities for funding to implement the prioritized capital improvements identified in this report. Securing sustainable sources of funding for parks and recreation will allow the York Parks Master Plan to be put into action and improvements to be realized within the existing park system.

General Fund

The General Fund for the City of York is comprised of 12 departments and budgets, including the Recreation Department. It is funded by taxes, fees, fines, service contracts, grants and transfers. The General Fund supports essential City services and other services defined by City Council. For fiscal year 2021, the Parks and Recreation budget is \$819,500, down 19% from \$1,013,095 in fiscal year 2020. The year-over-year reduction in budget is due to personnel cost savings, eliminating capital expenditures, and more closely aligning resources with needs.

Tourism Fund

Funded by the City of York's Hospitality Tax and Accommodations Tax, the Tourism Fund focuses on attracting tourists and revenue drivers including events, marketing, beautification, landscaping and other relevant capital projects. For fiscal year 2021, the Tourism Fund budget is \$566,000, up nearly 10% from fiscal year 2020's budget of \$515,000.

Impact Fee

As defined by the American Planning Association, impact fees are payments required by local governments of new development for the purpose of providing new or expanded public capital facilities required to serve that development. The South Carolina Development Impact Fee Act gives municipal and county governments the right to adopt impact fees. Local communities use impact fees to finance a wide variety of public facilities including schools, libraries, parks, and public safety facilities.

New Tax District

A new tax district is an additional way to fund parks and recreation projects specifically. Lake Wylie, SC provides a good example of this form of funding. In 2020, Lake Wylie residents voted in favor of creating a new tax district to support acquisition of greenspace property, conservation, historic restoration, passive recreation, and interactive community uses. Taxes levied by the new district will be capped at \$10 million in construction or land acquisition. If supported by residents, a similar funding mechanism can provide direct support for park and recreation projects in the City of York.

Debt Financing

Typically, general obligation bonds are debt instruments issued by states and local governments to raise funds for public projects that do not provide a direct source of revenue (i.e. roads, bridges, parks, equipment). The government entity can make interest and principal payments using any source of revenue available to them, such as tax revenues, fees, or the issuance of new securities. General Obligation bonds are viewed as a relatively safe mechanism to fund projects.

Local Fundraising

Establishing a 501(c)(3) non-profit organization in direct support of the local park system can provide a new opportunity for funding of park improvements and programs. With a strong community fabric, local fundraising in York can be successful by leveraging local businesses, organizations and private individuals. The non-profit organization can work with the City of York to secure program sponsorship, in-kind donations, and charitable donations as well as host events.

Naming Rights

According to a National Recreation and Park Association survey on local government officials' perception, parks and recreation is well regarded, viewed as a community asset for addressing community issues, and are used by most people in the area. Local park systems, therefore, provide a great opportunity for naming rights. Often facilities are family friendly, community focused, sport oriented and connected to youth, providing a variety of connections for aligning brands with parks. From complexes, fields and community centers, naming rights provide businesses an avenue to connect to their community and build brand loyalty.

Fee for Special Events

The City of York should review all events not sponsored by the City but where City park and recreation staff assistance or park facilities are utilized. For these events, the City of York should consider a flat rate or percentage fee as a way to provide funds directly back to the park system.

Grants

Grant Organization: South Carolina Department of Parks, Recreation & Tourism

Grant Name (if applicable): Parks and Recreation Development Fund

Description: The PARD grant program is a state-funded noncompetitive reimbursable grant program for eligible local government or special purposes district entities within each county which provide recreational opportunities. Each application must have the endorsement of its county legislative delegation members whose combined weight factor is more than 50%.

What they fund: Development of new public recreation facilities or enhancement/renovations to existing facilities

Funds available: PARD funds are generated from bingo taxes collected from July 1 –June 30 of each new fiscal year. The PARD funds are allocated to each county beginning July 1 of each new fiscal year. Each county will receive at least Twenty thousand dollars (\$20,000.00). 75% of the remaining funds is distributed to the counties based on the county's percent of the State population as published in 'Current Population Reports' by the Bureau of the Census.

Grant cycle: Monthly grant cycle. Application deadline is the 10th of each month.

Match amount: Eligible project costs will be reimbursed at a rate of 80%.

Grant Organization: South Carolina Department of Parks, Recreation & Tourism

Grant Name (if applicable): Recreational Trails Program

Description: The South Carolina Department of Parks, Recreation and Tourism (SCPRT) administers the Recreational Trails Program (RTP) under the approval of the Federal Highway Administration (FHWA). RTP, a federally funded program, receives its funding from a portion of federal gas taxes paid on fuel used in nonhighway recreational vehicles.

What they fund: Funds can be spent on both Motorized and Nonmotorized recreational trail projects — to construct new recreational trails, improve/maintain existing trails, develop/improve trailhead or trailside facilities and acquire trail corridors.

Funds available: Individual trail grants can range from a minimum of \$10,000 (\$12,500 would be the total project cost) to \$100,000 maximum (\$125,000—total project cost), with the exception of Motorized projects.

Grant cycle: Annual grant application

Match amount: the grant recipient must pay 100% of the cost of an item before submitting a reimbursement request for 80% of eligible costs.

Grant Organization: LWCF State and Local Assistance Program and South Carolina Department of Parks, Recreation & Tourism

Grant Name (if applicable): Land and Water Conservation Fund

Description: The LWCF is a Federal program that provides matching grants for the acquisition or development of outdoor recreation areas and facilities. The LWCF program has always required that any property acquired or developed with its funds be maintained in perpetuity as an active and viable outdoor recreation venue. Revitalizing existing LWCF properties is a topline priority. New park projects, especially those that address capacity issues, are eligible but will have to qualify through an on-site inspection, that all of the existing LWCF properties are in good shape and are being used appropriately.

What they fund: Acquisition, development and planning of outdoor recreation opportunities

Funds available: The minimum grant request is \$50,000 and the maximum is \$300,000.

Grant cycle: Annual LWCF spending is allocated to federal activities and a state financial assistance program.

Match amount: This is a reimbursable grant program requiring a 50 percent match.

Grant Organization: South Carolina Department of Transportation

Grant Name (if applicable): SC Transportation Alternative Program

Description: The program is a “grant” program under Federal regulation. It is not an “up-front” grant program and funds are available only on a reimbursement basis. Only after a project has been approved by the State Department of Transportation or Metropolitan Planning Organization and the FHWA division office, can costs become eligible for reimbursement. Costs must be incurred after FHWA division office project approval, or they are not eligible for reimbursement.

What they fund: Pedestrian facilities, bicycle facilities, streetscape projects

Funds available: \$1,834,589 Million - In areas of the State other than urban areas with a population greater than 5,000

Grant Cycle: Applications are accepted year round.

Match amount: The Federal government will pay for up to 80% of eligible project costs for a TAP project. A local match is required to pay for 20% or more of the remaining project costs.

Description: The NRPA provides information on grant and fundraising opportunities that are available for park and recreation agencies and affiliated friend groups and 501(c)(3) non-profits. There are no current grants available through the NRPA to support the City of York Parks Master Plan.

Grant Name (if applicable): PeopleForBikes Community Grant Program

Description: People for Bikes supports and advocates for the construction of trails that allow biking to be more accessible. They do not require a specific percentage match. People for Bikes will not consider grant requests in which their funding would amount to 50% or more of the project budget. Each application must have the support from an elected official, a bicycle industry representative, and another business representative.

What they fund: Bike paths, lanes, trails, parks, and bridges.

Funds available: Funding up to \$10,000.00.

Grant Cycle: Spring and a Fall grant cycle. Full applications due in April for the Spring cycle and in October for the Fall.

Match amount: Does not require a specific percentage match.

Funds available: Grants range from a minimum of \$250 to a maximum of \$5,000.







Q11 What does the phrase "York County Seat" mean to you?






















Q8 How would you rate the condition of the existing park facilities listed below?

Renovating and updating the parks are a great idea. However, it is alarming at how many softball/baseball fields you can find in York (8) but our kids have no where to go to kick a ball around with friends or even for a soccer team to practice. This is why all of our kids go to Rock Hill or Clover to play soccer. It's because they have the facilities and York does not. It would be nice to include a couple more field options with actual goals for our community to use. I have coached at the high school for 10 years now and this has been the biggest complaint I have heard from both players and parents. I do not see a need to have 8 diamonds in the community when we will only have one place (a multi-use field) where soccer can be played. Just my two cents.
I am pleased to see investment and planning in our Parks. I am very pleased to see all the proposed playgrounds. Unfortunately I think this plan highlights the fact that York fall short on providing reasonable access to soccer. Soccer is an inexpensive, safe and accessible sport for children but the city does not provide facilities for it. 8 baseball fields are proposed in this plan and only one mixed use field that could be for soccer. Our P&R department relies on the YMCA to provide a youth soccer program for York. They play on the front lawn of the filtrate plant. This is not sustainable. The area is infested with fire ants and someday Filtrate may decide not to let us use the space. We bring our child to Clover to play and we know lot's of our contemporaries who go to Rock Hill and Charlotte. I coach soccer at the High School and it is obvious our youth program is not feeding the high school program. I think two full sized soccer fields and 2-4 youth sized soccer fields should be a part of our plan. A strong youth soccer program run by York P&R would satisfy a need for families who live here and probably help attract young families to move here. I also would like to see power points and wi-fi available at some of our parks. I think in this post-covid world where remote work is more common it would help parents to be able to bring their child to practice, plug in their laptop and log onto public wifi.
